How might you react when someone you love dies?


Often times grief is frightening to us because it can be so painful and overwhelming. People wonder if they are grieving in the “right way” and if their feelings are normal.

While grieving, many people may experience some of the following:

- ✿ Difficulty controlling emotions
- ✿ Fatigue
- ✿ A feeling of guilt or anger
- ✿ Difficulty concentrating
- ✿ Inability to cope with everyday events
- ✿ Indecision
- ✿ A feeling as though the loss isn't real, disconnect from reality
- ✿ Confusion and forgetfulness
- ✿ Remorse
- ✿ Thought of suicide and death
- ✿ Sadness
- ✿ Restlessness
- ✿ Depression
- ✿ Change in appetite
- ✿ Anger
- ✿ Feeling that others do not understand and even worse that they may not care
- ✿ Difficulty sleeping
- ✿ Loneliness
- ✿ Financial concerns
- ✿ Starts things and unable to finish tasks or loses track of time
- ✿ Feeling of guilt
- ✿ A feeling of tightness in the throat or heaviness in the chest
- ✿ Frequent changes in mood
- ✿ Concerns about the future
